Sensors installed in strategic points within and outside the home will record humidity and temperature. A unique algorithm then evaluates temperatures, thermal performance, ventilation characteristics and the way the building is used.

The data collected is processed and presented in a report generated autonomously by the system.

This report informs the recipient of mould risk and identifies the causes of existing condensation or mould.

This can be used on its own or as an analytical appendix to a wider condition survey.

The results of the monitoring is processed within the system so avoids the hassle of number crunching, and the risk of disputes relating to the interpretation of complex data.

The tool puts the scientific evaluation of mould in occupied building at the fingertips of all surveyors, landlords and housing officers.



Its use can save money, resolve disputes and delivers healthier homes.

Identify, quantify, and solve moisture problems...

You can now purchase the Condensation and Mould Diagnostic tools and receive reports generated by the system. Kits include: 3 data loggers with accessories, instructions, and training. We also include the first report.

The system requires that the monitoring equipment is left in place for at least 2 weeks. The user then uploads the data from the loggers and sends it to us electronically. We then process the data using the analytic tool and generate the diagnostic report within a few minutes.

Measuring conditions over time is better than a single visit to look at a mould or condensation problem.




Such moisture related issues are dependant of water vapour production, ventilation, temperature and the thermal performance of walls and floors.


Conditions can change so long-term monitoring is needed to assess the risk or cause or mould.
